FAMILY CAMPING CODE OF CONDUCT

This Code of Conduct applies to all attendees and is in place to protect all attendees, staff and volunteers.

Please review all items below with all attendees of the family before signing and again before arriving at property.

Family Bubbling

Booking parties should consist of one family bubble. While on-site, attendees are required to maintain their bubble and stay safely distant from others at all times. This includes adults and youth.

Note: "Family bubble" is used in accordance to align with Ontario's Public Health use.

Notification Upon Arrival and Departure

Each member of the booking party is required to sign in at the camp office upon arrival and prior to accessing any other areas of the camp property or their accommodation.

At least one member of the booking party is required to sign the group out at the camp office upon departure.

Check-In and Check-Out

Woodland Trails Scout Camp:

Check-In & Check-Out is available at the following times. Check-in will be available till 7:30pm on Friday, but no later than 7:00pm on other days.

Tuesday: Check-In NA / Check-out by 11:00am

Wednesday: CLOSED

Thursday: Check-In from 9:00am / Check-out N/A

Friday: Check-out by 11:00am /Check-In at 4:00pm-7:30pm

Saturday: Office open 9:00am-5:00pm

Sunday: Check-out for weekend guests before 4:00pm

Monday: Check-out by 11:00am /Check-In from 11:00am

Guests will be required to submit a declaration of no Covid-19 symptoms before entering the site. They cannot use the property for isolation purposes.

Camp Samac:

Guests are welcome to check in any time between 1:00pm and 5:00pm. Check in before 1:00pm and after 7:00pm is not permitted. Guests are asked to vacate their accommodation or site by 10:00am on the day of departure, but may continue to enjoy camp up until and no later than 1:00pm. Sign out is required upon departure.

Guests will be required to submit a declaration of no Covid-19 symptoms before entering the site. They cannot use the property for isolation purposes.

Camp Opemikon:

Guests are welcome to check in any time between 1:00pm and 7:00pm. Check in before 1:00pm and after 7:00pm is not permitted. Guest are asked to vacate their accommodation or site by 10:00am on the day of departure, but may continue to enjoy camp up until and no later than 1:00pm. Sign out is required upon departure.

Guests will be required to submit a declaration of no Covid-19 symptoms before entering the site. They cannot use the property for isolation purposes

Supervision of Youth

Youth under 18 years of age are to be accompanied by a parent/guardian from their bubble at all times. This includes at program stations, on trails, in picnic areas, at the waterfront, during play, and in all other areas of property.

Mask and Physical Distancing

Masks are required at all times at program stations, at the camp office, in parking lots, and in any other area or circumstance where 2 metres of physical distancing is not possible. All guests must stay a minimum of 2 metres away from members of other family bubbles at all times.



Leave No Trace

Leave No Trace principles should be observed at all times. Guests are asked to refrain from altering or damaging any natural features and habitats. For more information, please see <u>leavenotrace.ca</u>.

Alcohol and Drugs

Consuming alcohol, cannabis, or any illicit substance is strictly prohibited. At no time should any of these items be brought on a Scouts Canada property. If staff or key volunteers believe that you may be under the influence of these substances at the time of arrival or at any time while on site, you may be asked to leave the property.

Pet-Free Environment

Pets are not permitted on Scouts Canada properties. For more information, please see Animals at Scout Properties and Activities Standards.

Cancellation Policy

Scouts Canada's Summer Adventure Camp Cancellation Policy is as follows			
All Bookings	10% non-refundable deposit will be required to secure your booking.		
All Bookings	The remainder of balance is due 4 weeks in advance of the first day of your reservation.		
Bookings cancelled with more than 2 weeks' notice.	If a payment has been made in full, it will be refunded with the 10% deposit subtracted from the total reimbursed.		
Bookings transferred with more than 2 weeks' notice.	10% non-refundable deposit can be transferred to another booking at any Summer Adventure Camp, along with any additional payments you have made.		
Dookings Cancelled with less than 2 weeks' notice. No refunds* If cancellation is related to Covid-19 or Public Health direction guests may be required to attest to facts and/or provide support documentation of extenuating circumstances to be eligible refund.			
Scouts Canada will cancel a booking if you are not a current employee, registered volunteer or member.	10% deposit will be retained as administration fee, all other payment will be refunded.		
Scouts Canada cancels booking due to extenuating circumstances.	Transfer 100% of payment to another booking or refund 95% of total payments received.		

Scouts Canada will not be responsible for any emergency cancellations necessary due to natural disaster, fire, accident, government regulation, pandemic, disaster, or any other emergency beyond their control, however they will try and find an alternative date to transfer your reservation to, should that be an option.

Commitment

Our behaviour reflects Scouts Canada's values, promise and law and thus protects the safety and well-being of all attendees, staff and volunteers. We will set an example that we would wish others to follow.

WE WILL:

- Remember that our conduct must always be obviously safe to others and that our intention does not make a situation safe.
- Follow our youth protection policy at all times.
- Follow all safety requirements of Scouts Canada.
- Notify Scouts Canada if any of the members of our family attending are the subject of any criminal investigation or any allegation or concern related to youth safety that may impact the safety of attendees.
- Treat everyone with fairness, respect and dignity.
- Always ask any attendee permission before making physical contact with them, and ensure that any physical contact is respectful and safe.
- Encourage people to speak up about issues related to personal safety that concerns them.

WE WILL NOT EVER:

- Behave in such a way that anyone could misinterpret our actions no matter how well-intended.
- Let adults contact youth attendees outside of your family outside of the Family Adventure Camping experience.
- Engage in any form of inappropriate relationship with any attendee or exploit them in any way.
- Ignore or trivialize abuse, harassment, bullying, hazing or bad behaviour.
- Have one to one contact with non-family youth online or inperson or in transit.

- Respectfully challenge behaviour or attitudes that we believe are inconsistent with Scouting values.
- Immediately report any concern for the welfare of youth or allegations of abuse to the authorities and to Scouts Canada's camp staff member, key volunteers, or by contacting the Safe Scouting Reporting line 1-800-339-6643.
- Immediately report any breaches of this code and Scouts Canada policy to Scouts Canada.
- We will subscribe to the Mission, Principles, Practices and Methods of Scouts Canada.
- We will abide by the By-Laws, Policies and Procedures of Scouts Canada.
- We will take, to the best of our ability, reasonable precautions to ensure the safety of all other attendees, staff and volunteers, as well as our personal safety.
- Swear or use inappropriate language in front any attendee.
- Use punishments and discipline that are demeaning, embarrassing or degrading.
- Smoke in front of youth, or on the Scouts Canada property at any time.
- · Consume alcohol or drugs while attending.
- Allow any allegation or concerns of abuse to go unreported.
- Engage in inappropriate conduct or behavior with attendees, including suggestive remarks threats, even in fun.

Release and Hold-Harmless

We understand that participation in Scouts Canada's Family Adventure Camp, running between July 2, 2021 to September 3rd, 2021, is voluntary and involves a certain degree of inherent risk that could result in possible accidents, physical injury, exposure to the COVID-19 virus, death or loss or damage to property.

We understand that the parents/ guardians of this family are strictly responsible for all conduct and actions taken, and are responsible for the supervisions of all minor's in the family.

We further understand that our family, and all other guests are attending as visitor's, and not as a members of Scouts Canada. As such, we understand only staff and key volunteers are trained and screened in accordance to Scouts Canada's Bylaws, Policies and Procedures.

We as a family have reviewed the Summer Camp Guide, FAQ and understand all of the rules, guidelines and Covid-19 Safety protocols in place for Family Adventure Camp. We will treat the property with respect, follow any fire ban regulations and understand that it is prohibitied to bring fireworks, motorized vehicles (boats, atvs, dirtbikes or drones) or drugs and alcohol into the property.

After carefully considering the risk involved, and all items outlined above, we hereby release, hold-harmless and waive all claims associated with this activity which we, and our family attending may have against Scouts Canada, its properties, employees, officers, directors, agents, volunteers and members.

We have read, understood, agreed to the Code of Conduct above, and will abide by such as a condition of attendance. We understand that violation of the code of conduct may result in our removal from site and possible membership implications and/or ramifications.
